# Deployment

- ONYX Owls are deployed as bespoke, client-specific AI instances, with each deployment logically isolated
- Each OWL is configured and customised at deployment to reflect the client's workflows, operating style, and intended use cases
- Deployment includes a structured onboarding process, covering prompt usage, operating boundaries, and usage training
- Access to each Owl is limited to named, licensed users, with user provisioning and removal controlled by the client
- ONYX Owls operate within explicitly defined functional boundaries and do not autonomously expand capabilities or behaviour
- The assistant does not connect to external systems or live environments unless this is explicitly agreed and configured
- Ongoing updates improve the assistant's functionality without affecting client isolation, access controls, or deployment boundaries



# Data Handling

- ONYX Owls only process client data provided by the client (e.g. no external access to public data or cross contamination)
- Data is processed solely to configure and operate a bespoke AI assistant for the client and is not reused, shared, or repurposed
- The client remains the Data Controller; ONYX / service partners act strictly as Data Processors under documented instructions
- All data is processed and stored within the EEA, using EU-based Microsoft Azure infrastructure via OpenAI
- Strong security controls are applied, including AES-256 encryption at rest, TLS encryption in transit, and role-based access controls
- Any data breach would be notified within 24 hours, with full support provided for investigation and regulatory obligations
- Upon termination or request, all data is returned or permanently deleted, with deletion certification available
